

Five Years of First-Year Composition: A Librarian Reflects, is an academic librarian's review of teaching information literacy to English composition classes. The reflections are based on classroom instruction, worksheet assessments, and student feedback.


- Plus: More engaged students as a result of new classroom design
- Delta: Plagiarism


2019

Self Assessment: Improved Database Searching Skills*





*No data for 2015 as the survey started in 2016.

A summary of the library instruction self-evaluation survey finds that, after an information literacy class, the majority of students increased their level of research skills from beginners to intermediate (39%), or intermediate to advanced (42%).

- 1. Student's ability to cite information: Advanced intermediate
- 2. Student's ability to locate quality information: Advanced
- 3. Percentage of faculty that requested instruction: 42%
- 4. Number of students in study: 1,818

Conclusion and References

Learning how to write and cite is fundamental to student success. Teaching information literacy to first-year composition students is a worthy challenge as they gain confidence in their ability to locate, use, and evaluate sources.
