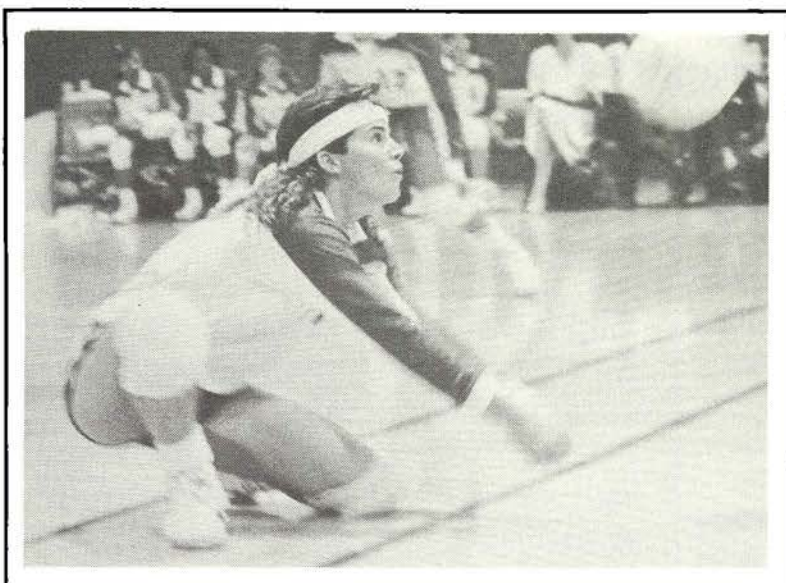

VOLLEYBALL FINISHES FOURTH IN LSC

TWU volleyball has turned the corner. A fourth place conference finish, three players nominated to all-conference teams and four players selected to the All-LSC Academic Team, a winning record - one can easily see why the TWU volleyball team is so proud of their first year of competition in the Lone Star Conference

The Pioneers won their last four conference matches surging into fourth place out of nine LSC teams. The 9-7 conference and 16-12 overall won/loss record is coach Troudt's best since arriving at TWU in 1986.

TWU won six straight matches during one stretch of the schedule, and defeated seven of their last ten opponents,

Tennis Goes 10-1

"Best Fall Season Yet"

The Pioneer tennis team won the first ten matches of the fall season dropping only their final match and finishing the fall schedule with a 10-1 record.

TWU defeated rival Texas Wesleyan University to start the winning streak. Cameron University, a Lone Star Conference member, ended the string of victories by handing the Pioneers a 8-1 defeat.

Freshman Elizabeth Simmons, from Carrollton, TX, lead her team with 19 wins. Senior captain Vivian Rodriguez won 11 matches at the very tough #1 singles position.

including a three game sweep of conference rival East Texas.

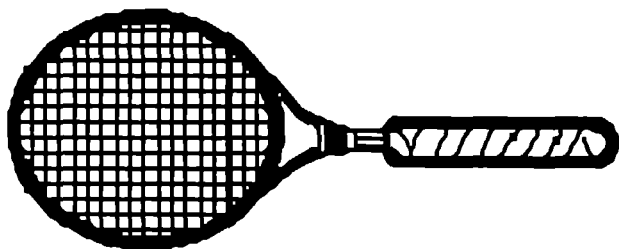
The six match winning streak was ignited by a five match romp at the Missouri Southern Invitational as the Pioneers captured the tournament championship. TWU also proved to be a tough competitor on their home court, posting a 7-3 won/loss record.

Fourth year coach Sandy Troudt was pleased with her team's overall performance this year. "I'm very proud of our team's accomplishments this fall, considering it was our first year in the conference and that we do not have one senior on the team," said Troudt. "I believe we will learn lessons from both our victories and our close defeats. I am excited for the 1990 season because our freshman class is very balanced and talented, and will really benefit from spring workouts."

Three Named to All-LSC Volleyball Team

Junior setter Michelle McGuire, from Lewisville, TX, and junior outside hitter Becky Martin from Arlington, TX, received the honor of being selected to the All-LSC second team for volleyball. Junior Nancy Svoboda was named to the honorable mention team.

McGuire was second in the conference in assists with a 10.57 per game average. She was 10th in the nation and led her team in aces (66) and attack percentage (.270).

"Michelle was a major reason our team attack percentage improved from .124 last year to .207 this season," said Sandy Troudt. "She was the most consistent performer on the team with really only one poor outing. She made the younger hitters feel comfortable and capable on the court," Troudt said.

Martin was the only player in the conference to be selected LSC player of the week twice. She led her team in kills per game and passing, and was second in aces and digs, showing her ability to dominate in all areas. "Becky's intense desire to compete made her invaluable in tough situations," commented Troudt. "She really is a great all-around player."

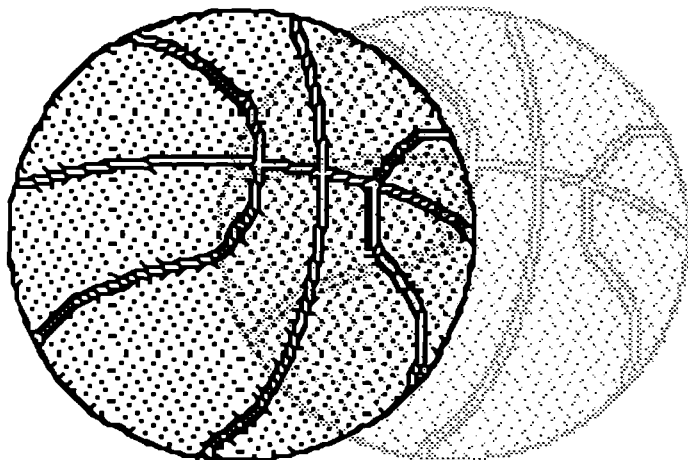
The Pioneers also placed junior captain Nancy Svoboda on the LSC honorable mention team. Svoboda led her team in digs and was second in blocks. She was ranked 10th in the nation in digs for several weeks during the season.

Basketball has 5-0 start

The Texas Woman's University basketball team has tipped off the 1989-90 season in style winning their first four games of the season. The Pioneers have defeated their first five opponents by an average of 29 points per game and have been led by a very balanced offensive attack.

Tri-captains Amy Kimm (Senior), Lori Biewen (Graduate), and Peggy Allen (Junior), have provided the experience and leadership necessary to launch TWU into what will be one of the most exciting season in recent years.

Allen was selected the Lone Star Conference Player of the Week for the first week of basketball action and



currently leads the LSC and her team in scoring with a 23.7 points per game average. Junior Shonny Vanlandingham is ranked ninth in the conference in scoring average (15.5 ppg).

"Our team's motto is "This is the year", commented head coach Kaycee Crump. "And that's exactly how my veterans feel about the season."

The strength of this year's squad lies in their depth and experience. This is Coach Crump's most talented group of players since she took the job four years ago. "We have fourteen women who are exceptional people and solid

Gymnasts set high goals

Being one of the best teams in the nation year after year brings with it a certain amount of pressure and expectation. The Texas Woman's University gymnastics team understands this concept quite well. They also realize that the path to the National Championships is getting crowded and the journey will be more difficult.

The Pioneers will have to maneuver around the toughest gymnastics region in the NCAA Division II. Three teams from the Central Region, S.E. Missouri, Winona State, TWU and Air Force went to the National Championships last year and finished 2nd, 6th, 7th and 8th respectively. Joining the region for the first time will be former Division I competitor Houston Baptist University, who will be an immediate contender for the regional and perhaps national title. Although the region is loaded, one of these four quality teams will probably be left behind. The Pioneers must focus their energies on finishing in the top three in the Central Region.

Coach Frank Kudlac faces this challenge with a solid team who has gained great experience over the past three years of national competition, but will be without two top performers, Cheryl Whitman and Julie Skiles. Whitman (lost to graduation) and Skiles (may be red-shirted due to knee injury) held all of the team's school records between them.

Setting the pace this season is senior captain Donna Drury and junior co-captain Lisa Woody. Both gymnasts know what it takes to return to the National Championships and are determined to lead their team back down that path.

Kudlac feels that the addition of gymnastic assistant Joe Rovegno will greatly benefit his team and will enable the Pioneers to increase their difficulty on routines. "Joe is an excellent technician and spotter and has already given our team a real boost," Kudlac said. "We have been able to double the work output in terms of difficult skills."

The Pioneers will face a competitive schedule that will prepare them for the pressure of regional and national performances. TWU will travel to



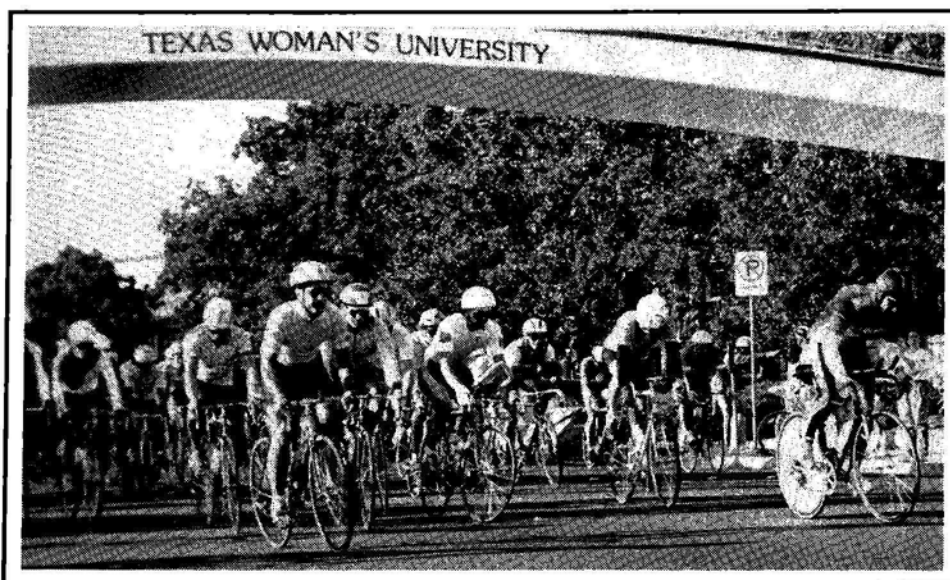
