### VPAA SEARCH CONTINUES

The search committee for the vice president for academic affairs is continuing its work following interviews with five finalists in May and June. The group will submit its final recommendations to Dr. Carol Surles (president's office) the week of July 10. "Dr. Surles will make the announcement when she has reached a final decision," said Dr. Janice LaPointe-Crump (performing arts, dance), who chairs the search committee.

Two of the five candidates have withdrawn their names from the list of finalists: Dr. Wilkes Berry (academic affairs) and Dr. Linda Bain. Berry submitted a letter to the search committee in early July, requesting that his name be removed from consideration. "I stated in my letter that professional and personal commitments made it inadvisable for me to remain as a candidate," he said. Bain, former dean of the School of Communication, Health and Human Services at California State University-Northridge, withdrew her name after she accepted the position of provost/vice president for academic affairs at San Jose State University (Calif.).

Three candidates continue to seek the position: Dr. Betty Greathouse, dean of the School of Education at California State University-Bakersfield; Dr. Patricia Cormier, vice president for academic affairs and professor of educational leadership at Winthrop University in Rock Hill, S.C.; and Dr. Beverly Byers-Pevitts, dean of the College of Humanities and Fine Arts and professor of communication studies and theatre at the University of Northern Iowa in Cedar Falls.

# TWU REGENTS SELECT NEW CHAIR, VICE CHAIR

The TWU board of regents elected a new chair and vice chair during their regular quarterly meeting on Fri., June 23, which was held at the TWU Institute of Health Sciences Houston Center. Board members **Nan Bailey** of **Flint** in East Texas and Sheila Whitaker-Kellagher of Dallas were elected chair and vice chair, respectively.

Bailey, appointed to the TWU board of regents in 1993 and sponsored by Sen. Bill Ratliff, is a community volunteer with more than 10 years of experience in teaching mathematics. A native of Tyler, Texas, she holds a bachelor's degree in mathematics and French from Hollins College, and she earned her master's degree -- also in mathematics -- from George Mason University. She said, "I am so pleased to have the opportunity to continue to serve on TWU's board of regents. I feel particularly fortunate to be able to work with President Carol Surles and her executive staff at TWU. I also would like to affirm my commitment to our distinct and unique mission: to offer education of the highest quality in an environment that empowers the full development of women."

Bailey serves as a volunteer for the Family Violence and Sexual Assault Institute and the Tyler Junior College SOS program. She is a member of several professional organizations, including the National Council of Teachers of Mathematics and the American Association for the Advancement of Science. Her mother, Martha Jo Hawes Hutchins of Tyler, graduated from TWU in 1943; her grandmother, Willie Lain Hawes, was also a TWU alumna.

TWU alumna Sheila Whitaker-Kellagher, president of TruCare Health Systems in Dallas, was appointed to the university's board of regents in October 1994 by former Gov. Ann Richards and was sworn in by TWU alumna Judge Maryellen Hicks of Fort Worth in a unique ceremony. She earned her bachelor's degree from TWU in physical therapy.

Justin residents are invited to attend the grand opening of the TWU CARES Health Center outreach clinic on Tues., July 11, from 1 to 5 p.m.. Housed in the Justin Municipal Center on the corner of College and 5th Streets, the clinic will provide a variety of services to Justin residents to help them lead healthier lives.

Refreshments will be provided during the grand opening, and the center's staff will offer screenings for nutrition, diabetes, cholesterol and other health concerns. The staff also will schedule appointments for later dates to provide the following services: physical examinations, cholesterol screenings, immunizations, hearing and vision screenings, pregnancy tests, EPSDT screenings, sports physicals, diabetes screenings, well baby checks and nutritional education.

The outreach clinic, part of the TWU CARES Health Center, is managed by the TWU College of Nursing. The goal of these clinics is to provide primary health care for low-income families. # PUBLIC INFORMATION RESTRUCTURES, PROMOTES STAFF

Kathleen Gigl (institutional advancement) announced in June a restructuring within the office of public information that "will enable staff members to focus on two main areas -- news and information, and publications -- to strengthen their roles as consultants and advisors in the areas of news, communications strategies, publications and related fields. I am pleased to make this announcement because these changes will increase public information's contributions to the TWU community and to the institution itself as we reaffirm our mission as a university primarily for women."

The office of public information, which will retain that name, now includes the division of news and information and the division of publications. Ann Hatch has been named director of news and information; she will oversee those specific operations, as well as budget and general office management for public information. Hatch, who joined the office of public information in August 1988 as assistant director of public information for media relations, has served since June 1, 1994, as interim director of public information.

"I am excited about the opportunities and potential that our new structure will give to news and information," said Hatch. "While we will continue to provide editorial support for publications, the news staff will focus on news as it happens, plus short-term and long-term communications strategies. We will continue to build on our media relations program and expand our news efforts. And we look forward to creative, collaborative efforts and planning with publications." *TWU Update*, the *TWU Times*, news and similar communications vehicles will continue to flow through news and information.

Carolyn Barnes, formerly media relations associate, has been appointed director of publications. Barnes previously was associate director of the office of public affairs and news and information at the University of North Texas before she joined TWU's public information staff in 1992. "We're reassessing everything that we do in publications in order to adapt to the changing needs and expectations of the university," said Barnes. "Our work is challenging, and the results will be rewarding for both the staff and TWU."

In addition to these changes, Gail Parr has been promoted to a new position, public information assistant. Staff members in news and information include Hatch, an additional writer (who will be hired in the near future to replace Barnes) and Parr. (Joyce Edmundson and Fred Ballard, who both work in the information booth, also report through news and information.) Staff members in publications include Barnes, the assistant director for publications, Susan Sponsler, and designers Kenn Kotara and Mark Harris. Several student assistants and one graduate assistant support staff members in both divisions.

#### LIS OFFERS DISTANCE LEARNING IN WEST TEXAS

The TWU School of Library and Information Studies will offer several courses this fall, in cooperation with West Texas A&M University at Canyon, that lead to the Master of Library Science degree and/or the Learning Resources endorsement for school librarians.

"Using distance learning, students in Canyon learn simultaneously with students at TWU in Denton through interactive television in a setting that brings to the classroom the same technology used for video conferences," said Dr. Keith Swigger (Library and Information Studies). "Students in Canyon receive the same instruction as those in Denton, and the technology enables them to participate fully in class discussions and other activities." WTAMU provides instructional support services such as library resources and computer laboratories.

Courses that will be offered in the fall include: Information Storage and Retrieval, Monday, 1 to 4 p.m. (LS 5013); Cataloging and Classification, Wednesday, 6 to 9 p.m. (LS 5103); Information Sources and Services, Monday, 6 to 9 p.m. (LS 5263); and Library Management, Thursday, 1 to 4 p.m. (LS 5383). TWU accepts up to 6 credit hours of transfer credit in a relevant discipline from WTAMU as part of the 36-hour degree requirements.

Students may enter the program at the beginning of any semester, according to Swigger. For more information, call ext. 2602.

#### FACULTY GRANTS CONTINUE

Faculty members from several departments, colleges and schools have received grants during the 1994-95 academic year. Several are listed below.

- Dr. Delaina Walker-Batson (communications sciences and disorders) has been awarded a \$100,000 grant from the National Institute on Deafness and Other Communication Disorders for her research project, "Pharmacologic Modulation in the Treatment of Aphasia." The grant period will continue until Sept. 29, 1996.
- Dr. Kathleen Millay and Dr. Allan Bird (communication sciences and disorders) were awarded a \$172,377 subcontract from the Region 8 (East Texas) Education Service Center of the Texas Education Agency for their education project, "Training Projects in Speech-Language Pathology in East Texas." The grant period will continue until Aug. 31, 1995.
- Sherrie Taylor (business and economics) was awarded a \$4,000 grant from the U.S. Small Business Administration for her education project with the Small Business Institute Program. The grant period will continue until Sept. 30, 1995. "The Small Business Institute program is a contractual agreement between the Small Business Administration and a four-year college or university," Taylor explained. "The SBI program uses senior-level undergraduate or graduate-level students, under faculty supervision, to provide business counseling and technical assistance to small business clients."
- Dr. Joanette McGadney (Nursing, Dallas Center) and Dr. Oneida Hughes (Nursing) were awarded a \$5,000 grant from the Texas Higher Education Coordinating Board for their research project, "Obstacles (Perceived or Actual) Influencing the Attrition Rates of African-American and Hispanic Nurses." The grant period will end Aug. 31, 1995.

"When compared to the general Texas population, the nursing population has a significantly lower percentage of African-American and Hispanic nurses," McGadney explained. "The purpose of this proposal is to identify those obstacles that prevent minority nurses whose initial degree was an associate's degree or a bachelor's degree from applying for, being accepted, remaining in, or advancing to the master's or doctoral level in nursing."

- Dr. Lynn Wieck (Nursing, Houston) received a \$14,182 grant from the subcontract from Baylor College of Medicine for a proposal submitted to the National Institutes of Health. This award is for her second year of research on the project titled "Improving Hypertensive Care for Inner City Minorities." The grant period will continue until Aug. 31,1995.
- Dr. William Bartlett (Physical Therapy, Houston) received a \$75,669 grant from the National Multiple Sclerosis Society for his research project, "The Role of IGF-1 in the Regulation of Gliogenesis." The grant period will continue through Sept. 30, 1995.

"This project's goal is to determine whether IGF-1 is involved in the remyelinating capacity of CNS and to identify the cells producing it," Bartlett explained. In his final year of research, he will focus his attention on two projects. "One is to identify factors that regulate the expression of IGF-1 in the damaged brain and by macrophages in vitro. The second project will be to examine the expression of the IGF-1 gene in an animal model of MS, the Theiler's virus model."

- Dr. Elizabeth Kelly and Dr. Mary Newman (Nursing, Houston) received a \$9,612 grant from the March of Dimes Birth Defects Foundation-Texas Gulf chapter for their project, "An Assessment of the Health and Needs of Pregnant Women Who Are Homeless." The grant period will continue through Dec. 31, 1995. "This project will focus on the development and implementation of an assessment and case tracking program to ensure appropriate and continuing care for homeless pregnant women," Kelly said.
- Dr. Janice LaPointe-Crump (performing arts, dance) received a \$2,175 grant from the Mid-American Arts Alliance for a two-day residency with the Oakland Ballet. "This residency is part of TWU's collaboration with the University of North Texas Fine Arts Series, but TWU is the applicant for the MAAA grant," she said.
