Revised Cost of Attendance

EFFECTIVE SEPTEMBER 1935

The expenses of attending the Texas State College for Women depend largely upon the disposition and habits of the student. Including the College charges for tuition, board, room, fees, and textbooks, and the incidental expenses for travel, uniforms, laundry, etc., the cost should vary from \$350.00 to \$500.00 for the regular session of nine months.

The College charges for the NINE MONTHS' SESSION are as follows:

Tuition	\$ 50.00
Book-rental, laboratory, medical, and student-activity fee (optional)	15.00
Room rent	60.00
Board	160.00
Total	\$285.00

In addition to the charges enumerated above, each student, on registration, is required to make a book, laboratory, and material deposit of \$6.00. This \$6.00 deposit is refundable at time of withdrawal if no damage or loss has been incurred by the student.

Of the total of \$285.00 in charges enumerated above, one-half, or \$142.50, is payable each semester. The deposit of \$6.00 is required only once each session.

Payment of these charges may be made under any of the following three plans:

Plan 1. Payment of the entire amount of \$142.50 (plus deposit of \$6.00, a total of \$148.50) at the beginning of the semester, and the second payment of \$142.50 at the beginning of the second semester.

Plan 2. Payment of the \$142.50 each semester as follows: first semester, \$52.50 (plus deposit of \$6.00, a total of \$58.50) on entrance, \$22.50 on or before October 10, \$22.50 on or before November 10, \$22.50 on or before December 10, \$22.50 on or before January 10; second semester, \$75.00 on entrance, \$22.50 on or before March 10, \$22.50 on or before April 10, \$22.50 on or before May 10.

Plan 3. Monthly payments: first semester, \$32.50 (plus deposit of \$6.00, a total of \$38.50) on entrance, \$27.50 on or before October 10, \$27.50 on or before November 10, \$27.50 on or before December 10, \$27.50 on or before January 10; second semester, \$37.50 on entrance, \$35.00 on or before March 10, \$35.00 on or before April 10, \$35.00 on or before May 10.

(Note: A student who has not attended the College during the first semester, and who enters at the beginning of the second semester, is required to pay the \$6.00 deposit, described above, on entrance, regardless of the plan of payment adopted. This deposit of \$6.00 will be added to the amount payable on entrance.)

Each student is requested to notify the cashier of the College, at the time of registration, as to which of these three plans of payment she desires to use. If a different plan of payment, other than one of the three enumerated above, is desired, correspondence is invited.

In the above enumeration of charges, no refunds will be made, on withdrawal, for tuition, book-rental, laboratory, medical, and student-activity fee, or room rent; but payments of board will be refunded in full from the date of fifteen days after withdrawal.

SMITH-CARROLL CO-OPERATIVE DORMITORY

The cost of room and board to students in Smith-Carroll co-operative dormitory is \$25.00 per semester less than in the regular dormitories, i.e., \$85.00 each semester for room and board instead of the regular charge of \$110.00 each semester. LIGHT HOUSEKEEPING

Students who are unable to pay the cost of room and board in the regular dormitories or in Smith-Carroll will be permitted to make light housekeeping arrangements in organized groups under the direction of the College authorities. For details regarding light housekeeping address the Dean of Women, Texas State College for Women, C.I.A. Station, Denton, Texas.

EXPLANATION OF FEES

1. The payment of the tuition fee of \$50.00 (\$25.00 each semester) entitles the student to the following privileges: (a) Instruction in the various non-laboratory classes; (b) the use of all books belonging to the College Library; (c) the instruction and training in all subdivisions of the Department of Physical Education including the use of bathing suits for the swimming pool.

2. The book-rental, laboratory, medical, and student-activity fee of \$15.00 (\$7.50 each semester) entitles the student to the following privileges: (a) The use of required textbooks; (b) laboratory fees; (c) the service of the College Physician and the regularly employed nurses (however, in the case of illness requiring the employment of a special nurse and other extra expense, the actual cost must be met by the student); (d) Artists Course ticket for the session; (e) Lecture Course; (f) subscription to the Lass-O and the Daedalian Quarterly.

(In case the student desires to buy her own textbooks, and to pay laboratory fees, and to pay for Artists Course ticket and subscriptions to the Daedalian Quarterly and the Lass-O, singly, these items, as enumerated in paragraph 2. will amount to from \$30.00 to \$60.00 per session, depending upon the number of textbooks required. The textbooks will cost from \$15.00 to \$40.00; the laboratory fee is \$2.00 per semester for each course; the medical fee is \$3.00 per semester; the Artists Course for the session will cost \$3.00; the Lass-O and Quarterly are \$3.00 per year. It is therefore greatly to the student's advantage to pay the optional fee of \$7.50 per semester and so receive these privileges without further expense.)

3. The book, laboratory, and material deposit fee of \$6.00 is refunded to the student upon her withdrawal from the College when she has returned all books belonging to the Library, made settlement for all damages due to carelessness in the laboratories and to materials belonging to the College, and has settled all indebtedness to the College.

Note:—A student carrying less than twelve hours of work will pay tuition and fees on a graduated basis, according to the number of hours for which she is registered.

The tuition fee of \$50.00 per regular session of nine months is that authorized by law. Therefore, this amount is subject to such changes as may be made from time to time by the Legislature.

REDUCTION IN MUSIC FEES

The charges for individual lessons in applied Piano, Voice, and Violin, according to the teacher selected, have been abolished, and, in their place, a uniform charge for every teacher has been substituted, and this charge reduced to a flat fee of \$25.00 for one lesson a week and \$45.00 for two lessons per week per semester.

In theory, the charge of \$7.50 per semester for Harmony, of \$7.50 for Orchestration, of \$7.50 for History of Music, of \$7.50 for Appreciation, of \$7.50 for Ensemble, of \$4.00 for Orchestra, and of \$4.00 for Choral, have all been abolished. The fee of \$7.50 for Class Piano is retained.

FEES FOR OUT-OF-STATE STUDENTS

In accordance with the new tuition law passed by the 43rd Legislature, which provides for a reciprocal tuition arrangement for students from other States, students entering the Texas State College for Women, College of Industrial Arts, from States which have similar state colleges for women will be charged here the same tuition which they would pay in the state-supported woman's college in their own state, provided that the minimum charge will be \$50.00 for the nine months' session. The States to which this reciprocal arrangement applies are Oklahoma, Mississippi, Alabama, Florida, Georgia, North Carolina, South Carolina, and Virginia. Students from other States will be charged the regular tuition fee of \$50.00 for the nine months' session.

SUMMER SCHOOL FEES, 1935

Cost of Attendance

The charges for each six weeks' summer session, including tuition and fees, will be \$48.00, divided as follows:

Tuition	\$10.00
Book-rental, laboratory, medical, and student-activity fee (optional)	3.00
Room rent	8.00
Board	27.00
Total	\$48.00

Of the total of \$48.00, \$28.00 is payable at the beginning of the term and \$20.00 at mid-term.

Deposit

In addition to the charges enumerated, each student is required to make a book, laboratory, and material deposit of \$6.00 and each dormitory student a linen deposit of \$2.50. All of the \$6.00 deposit and one-half of the \$2.50 deposit are refundable at the time of withdrawal.
